This Memorandum of Understanding is made between the National Fishing in Schools Program (NFSP) and the school/district listed below ("NFSP Installed School")

1. Purpose

- 1.1 The Parties recognize and agree that NFSP is providing the "Fishing in Schools" program to the school for the purpose of having its teacher(s) implement the curriculum into its PE and/or other academic agenda in the NFSP Installed School.
- 1.2 The purpose of this document is to express the non-binding understanding of each Party to participate in supporting this cooperative arrangement.
- 2. Commitment to the mutual interests of parties
- 2.1 It is intended that the school participates in the National Fishing in Schools Program for a period of at least three years. After the initial unit is completed, the school shall become a full-fledged participant in NFSP.

3. Scope of Cooperation

- 3.1 The Parties agree that they will work together to implement the curriculum into their school and to provide mutual input/feedback as to how to continually improve the program.
- 3.2 It is understood that during the participation in the program teacher(s) and students will be requested to provide feedback on the training, curriculum, equipment, practices, lesson plans, assessment guides, etc.
- 3.3 Fulfillment of NFSP Installed School commitment includes prompt recording/reporting of results and recommendations to NFSP for unit completion evaluations, lesson plan reviews and year end recap.

4. Relationship

- 4.1 The relationship among the Parties is that of supplier/client and at no time will any Party be deemed to be the agent of another. The Parties affirm that no partnership arrangement or form of representation of the other party is accepted or implied by the conditions of this Memorandum of Understanding.
- 4.2 No Party shall be liable to any other Party for any matter arising from activities under this Memorandum of Understanding.

- 5. Term and Termination
- 5.1 This Agreement shall come into force from the date of the last signature and shall remain valid for a period of three years.
- 5.2 This Agreement may be terminated at any time by mutual written agreement of the Parties existing at the time of termination.
- 5.3 Subject to the contingencies mentioned above, either Party may unilaterally withdraw by providing sixty days written notice to the other Party.

6. Status

6.1 This agreement is not legally binding. No funds are committed and no legal obligations are created by this Agreement.
